- Minimum booking 2 hours - £250 **or** £225
- Additional Hours until midnight - £85 **or** £76.50 per hour
- After Midnight - £100 **or** £90 per hour

- Travel time - £70p/h
(First half hour of travel each way Included in shoot fee.)
